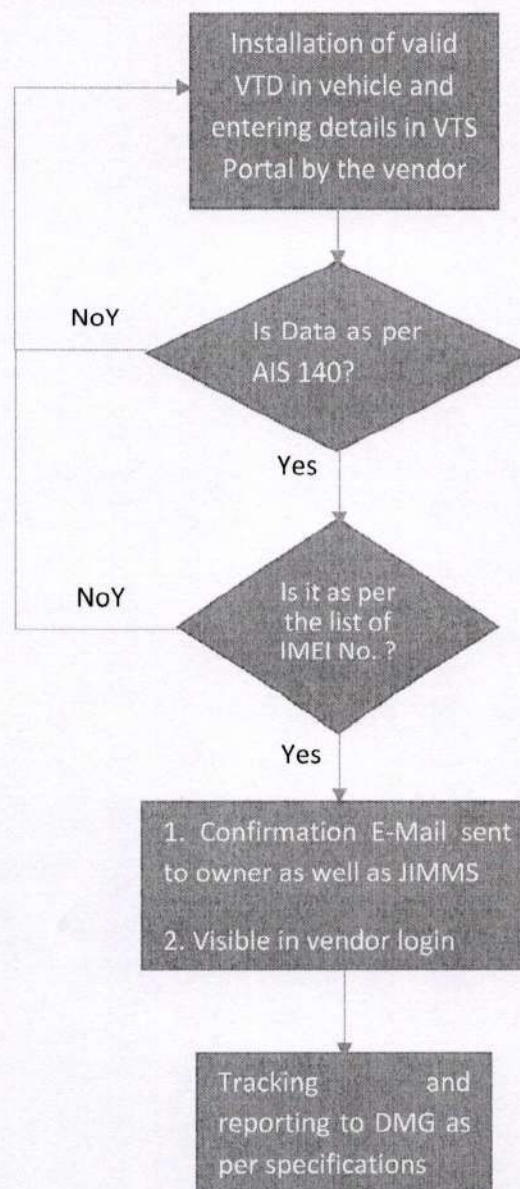

**PROCEDURE FOR REGISTRATION OF VTD**

1. Empanelled Vendor will provide the list of 1000 IMEI Nos. of the AIS 140 VTD that is being planned to be installed in mineral transporting vehicles plying in the State of Jharkhand.
2. SI will register all those IMEIs in the demo VTS portal on stage server provided by DMG against that empanelled vendor subject to availability of valid Bank Guarantees against them.
3. SI will provide a web interface (username and login) to each of the empanelled agency to register the installed device, vehicle no, other relevant details like primary and secondary sim no. etc.
4. SI shall ensure that no more than 1000 devices by any of the empanelled agencies are allowed to be installed till instructions are received from DMG.
5. Once the device is installed in a mineral transporting vehicle, SI will check the data of the device and if found to be in compliance with AIS 140 protocol standards, it will be registered in the database.
6. Owner of the vehicle will receive an acknowledgment email that the device is installed in his vehicle and is recognized by DMG Jharkhand.
7. Empanelled agency whose VTD has been installed in the mineral transporting vehicle will also receive an acknowledgment email about the registration of VTD.
8. Thereafter, tracking of vehicles and relevant reports will commence.

**Steps for Installation of VTD In Mineral Carrying Vehicles by Empanelled Vendor****Procedures:**

1. Once the device is installed by the empanelled vendor in a mineral transporting vehicle, the data of the device will be checked and if found to be in compliance with AIS 140 protocol standards, it will be registered in the database.
2. Owner of the vehicle as well as the empanelled VTD vendor will receive an acknowledgment email intimating that the device is installed in his/ her vehicle and is also recognized by DMG Jharkhand.
